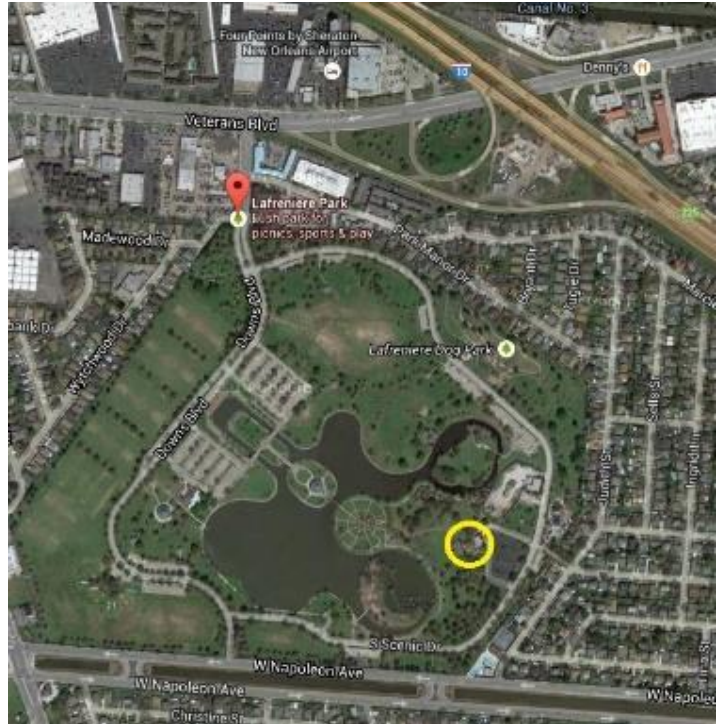

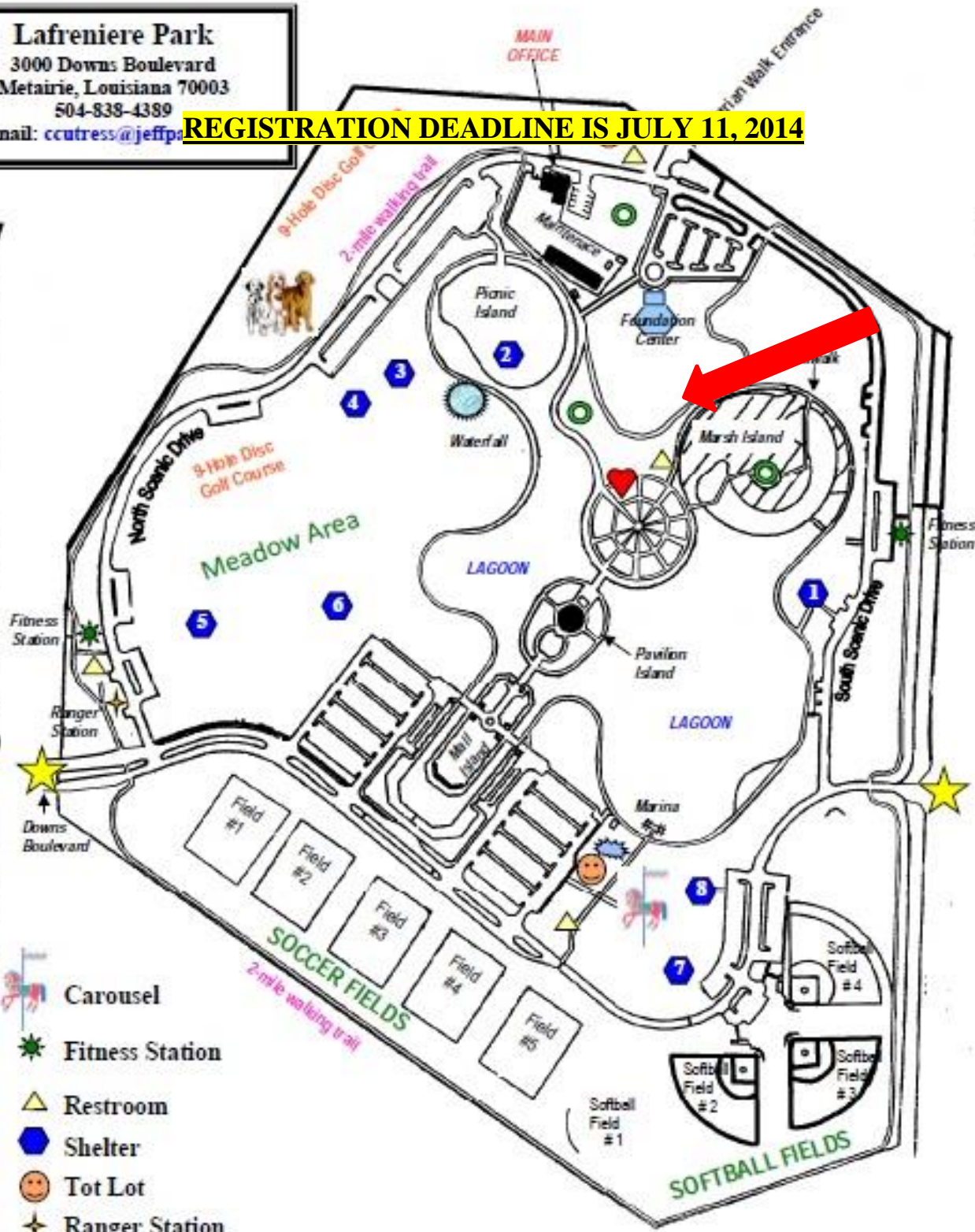

2014 Region 1 Teen CERT Camp Code of Conduct Form

This Code of Conduct is designed to ensure the success of this event. It will help maintain the safety and enjoyment of all attendees. Each parent is required to review this Code of Conduct with all persons attending the 2014 Region 1 Teen CERT Camp.

1. Each participant is expected to provide their full cooperation and shall be responsible for maintaining self-discipline and the standards of conduct outlined in this Code of Conduct.
2. All participants will be properly dressed and presentable at all times. Closed-toe shoes and provided safety gear **MUST** be worn during training at all times.
3. All participants are expected to participate in **ALL** scheduled events and trainings.
4. Youth participants are not allowed to play with or use **ANY** electronic devices during training sessions. No exceptions.
5. All participants are responsible for their own personal items and all items not belonging to a participant are off limits. Loss of personal articles is not the responsibility of the hosting agencies.
6. Each participant is personally responsible for any damage, breakage or loss of property that is the result of their negligence or action.
7. Snacks and Lunch will be provided to all participants. If a participant requires a special diet or has food allergies they should bring their own lunch and snacks.
8. Any participant requiring medical assistance or administering of any medication shall report this to an available Instructor.
9. The purchase, possession or consumption of alcoholic beverages or illegal drugs at the event will not be allowed or tolerated.
10. **NO** form or sexual, racial or any other form of harassment, bullying or misconduct will be tolerated.
